According to the Association's Articles of Association, as the number of persons properly standing for election equals the number of vacancies to be filled, the three candidates, being Mr. Chan Kai On Paul, Mrs. Kotewall Hau Yee and Ms. Ma Kar Yiu Caroline, shall be declared to be elected at the Annual General Meeting and voting procedures in Articles 35 (a) to (c) shall not be followed.
- 4. "SPCC Class of" would be your graduating year in Form 5 if you were under the Hong Kong Certificate of Education Examination (HKCEE) system, or in Form 6 if under the New Senior Secondary structure (implemented in the academic year 2009/2010), whichever applicable.
- 5. ANY ALTERATION MADE TO THIS FORM OF PROXY MUST BE INITIALLED BY THE PERSON WHO SIGNS IT.

- 8. Completion and deposit of this form of proxy will not prelude you from attending and voting in person at the Annual General Meeting or any adjournment thereof if you so wish.
- 9. The decision of the Association shall be final in case of dispute.
